**NOTE:-**

1. Candidates qualified in the ANGRAU – PG Entrance Test – 2018 are eligible for spot counseling.
2. More number of candidates than the number of available seats are called for counseling. Hence, seat cannot be guaranteed to all those candidates called for counseling.
3. The candidates who are given sliding option also advised to attend spot counseling.
4. The selected candidate has to pay the entire fee (Approx. 29,000/-) at the time admission on the day of counseling itself.
5. The selected students should join at respective colleges on or before 09.10.2018 positively.
6. The available seats may increase at the time counseling in view of 2<sup>nd</sup> round of ICAR admissions.
7. All admissions shall be deemed as provisional and subject to further scrutiny. The admission shall be liable for cancellation without notice at any stage during the study of the students if it is found that this admission is in any way repugnant to the rules/regulations or invalid by reason of incorrect or false information furnished by the applicants or their parents/guardians at the time of admission.
