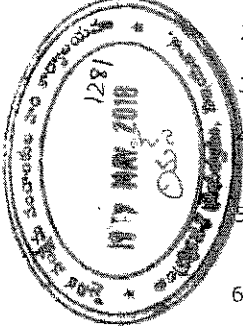

ORDER:-

In the GOs 1st, 2nd and 3rd read above, among others, orders were issued on priorities to be adopted for admission into Engineering Colleges and Medical/Dental Colleges etc., for the children of Ex-Servicemen and Defence personnel residing in Andhra Pradesh.

2. The Govt. of India, Ministry of Defence issued modified orders on priorities vide letter 4th and 5th read above. Based on the above orders, the Director, Sainik Welfare has requested to adopt the same priorities in the admission into Engineering College and Medical/Dental College etc., for the children of Ex-Servicemen welfare in toto wherever the CAP reservations are being implemented in Andhra Pradesh vide reference 6th read above.

3. In the circumstances stated by the Director, Sainik Welfare, Andhra Pradesh, Vijayawada in his letter 6th read above and also Ministry of Defence orders, Government hereby direct that the following pattern of priorities shall be adopted for admission into seats reserved for the Children of Ex-Servicemen and Defence Personnel who are natives of Andhra Pradesh State from the academic year 2018-19 onwards:-

Priority	Persons eligible
I	Widows / Wards of Defence personnel killed in action
II	Wards of disabled in action and boarded out from service
III	Widows/Wards of Defence Personnel who died while in service with death attributable to military service.
IV	Wards of disabled in service and boarded out with disability attributable to military service
V	Wards of Ex-Servicemen and serving personnel who are in receipt of Gallantry Awards : i) Param Vir Chakra ii) Ashok Chakra iii) Sarvottam Yudh Seva Medal iv) Maha Vir Chakra v) Kirti Chakra vi) Uttam Yudh Seva Medal vii) Vir Chakra viii) Shaurya Chakra ix) Yudh Seva Medal x) Sena, Nau sena, Vayu Sena Medal xi) Mention-in-Despatches.

VI	Wards of Ex-Servicemen
VII	Wives of : (i) Defence personnel disabled in action and boarded out from service (ii) Defence personnel disabled in service and boarded out with disability attributable to military service (iii) Ex-Servicemen and serving personnel who are in receipt of Gallantry Awards
VIII	Wards of Serving Personnel
IX	Wives of Serving Personnel

4. The above priorities are applicable for the Wards of Ex-Servicemen and Defence Personnel who are natives of Andhra Pradesh State only, wherever the seats are reserved for admissions in favour of them. Native means Ex- servicemen and Defence Personnel who have represented the State of Andhra Pradesh at the time of joining the service by declaring their permanent home address in Andhra Pradesh and are bonafide natives of the State.

5. The Director, Sainik Welfare, Andhra Pradesh, Vijayawada is requested to take further necessary action for strict implementation of these orders.
